- Species focussed

### Freshwater Pearl Mussel

Complex life cycle

Demands high quality aquatic environment

Vulnerable to land-based threats



#### Hen Harrier

- Specialist predator
- Indicative of ecosystem functionality
- Requires good quality habitats and abundant prey species
- Ground Nesting



### A Resilient Landscape

- Address wildfire risk by
  - Reducing the connectivity of fuel species in the landscape
  - Targeted Grazing
    - Right animal at the right place at the right time
    - Targeted rewetting
    - Strategic broadleaved tree planting

Breeding success linked to productivity in every part of the Food Chain


What do we mean by Landscape Level Actions?

  - Wild Bird Cover




# What do we mean by Landscape Level Actions

- Actions where co-ordination between farmers or between farmers and other stakeholders is necessary
  - Wildfire resilience
  - Fire Ponds







- Co-operation between farmers
  - Commonages



What do we mean by Landscape Level Actions

- Bonus payments for key deliverables
  - Hen Harrier nest payment
- Investment in Communities



What do we mean by Landscape Level Actions

- Project level support actions
  - Production of Landscape fire plans
  - Monitoring of key species

- Reform of Land eligibility rules for direct payments




