


Key Considerations for Farmers

- Space + Family interest in the tourism industry long-term.
- Enough units to make viable business
- Separate entry and divide from main farm activity
- Need the following:- Central Block for reception, office, kitchen, meeting point/couches and tables, linen store, shop, Washing Machines, Children's Play area

Types

Glamping, Cottages, Campervans, Bunkhouse/Student Farm Building into accommodation or Meeting place, Campsite /Tent Facilities, Shepherds Huts, Remote off grid units





Regulations

- Register for STR will be in place within 6 months each unit have a registered no. Failte Ireland are statutory agency to manage for EU.
- Planning Permission. new Guidelines for Planners and Owners which will treat rural areas differently to urban areas, even in RPZ area. Make a Plan, talk to planner and then draw up plans.
- **Insurance** Public Liability Insurance build Health + Safety into Plan.
- **Quality Assurance** Standards (not legal requirement yet)







Challenge

- Planning -be ready but don't apply until the Regulation changes in next few months!
- **Regenerative tourism** use old buildings is the best way to be sustainable
- On Call all the time during the season.
- Woodland areas fires so less likely get planning permission.
- Sewage and Water supply for full site.
- Investigate Glamping in Northern Ireland and Scotland (bothays)






